*Must be obtained from the local office of the Internal Revenue Service. Upon acknowledgment of the Corporation by Shaklee, this number should appear on all correspondence with Home Office, including sponsorship. You must attach a copy of the IRS notice of Federal Employer Identification Number Assigned or IRS letter 147C Confirmation of F.E.I.N. sent to you by the IRS. The F.E.I.N. and account information you supply Shaklee should always match IRS records. If you change information with Shaklee, you must also inform the IRS and obtain a new certification. Failure to do so may result in Shaklee having to withhold income from your bonus payments.

As a Corporate Distributor, it is understood and agreed that:

The Corporate Distributor will apply its best efforts to promote the sale of Shaklee products and the Shaklee Business opportunity in a positive manner favorable to both the Corporate Distributor and Shaklee Corporation.

The Corporate Distributor will be an independent contractor and not an agent or employee representative of Shaklee Corporation. Upon acceptance of this application by Shaklee Corporation, the Corporate Distributor will become an authorized Shaklee Family Member.

The *Statement of Privileges & Responsibilities of Shaklee Family Members* (P&R), receipt of which is acknowledged, sets forth the rules and policies of the Shaklee Compensation Plan. All rights and responsibilities will be determined by the P&R and other publications as may be amended from time to time. The Corporate Distributor agrees that it will abide by the documents and the rights and promises set forth in this Corporate Distributor Application, and that such agreement will be binding on its shareholders, officers, employees, agents and representatives.

No purchase other than the Shaklee Business Guide is necessary to become a Shaklee Family Member. No financial investment is required to obtain the Corporate distributorship.

Shaklee reserves the complete right to reject this Corporate Distributor Application for any reason whatsoever, including a determination by Shaklee that anyActive Guarantor is unacceptable to Shaklee for any reason.

Shaklee may terminate the distributorship immediately if the Corporate Distributor discredits the Shaklee name, breaches any of the requirements of the P&R, misrepresents Shaklee products by making claims contrary to Shaklee product literature or labels, or for other material breach of contract. In addition Shaklee may dissolve the Corporate distributorship immediately upon the deletion or addition of an Active Guarantor, as set forth below. In this connection, the Corporate Distributor agrees that it will notify Shaklee in the event of proposed changes in the Active Guarantor(s) set forth below and understands that Shaklee retains the right to accept or reject continuance of the Corporate Distributor Agreement.

Instructions for Corporate Distributor Applicants

Under the *Statement of Privileges & Responsibilities of Shaklee Independent Distributors* (P&R), authorized members who wish to operate as a Corporate Distributorship must apply to Shaklee as described below.

Please note that a distinct Corporate Distributorship name is required to identify the Corporation on Shaklee records. The corporate name selected should clearly identify the business entity as a corporation (through use of such words in the business name as "Corporation", "Inc.", "Incorporated", "Ltd.", "Corp.", etc.) but must not be a name that could be misunderstood by the general public as being a subsidiary, branch office or affiliate of Shaklee Corporation. In particular, the Corporate name may not include the trademark or trade name SHAKLEE. Furthermore, Shaklee Corporation reserves the right to reject any corporate distributor application and reject any proposed corporate distributor name if it is deemed objectionable or if it is confusingly similar to the business name of another Shaklee distributorship.

Before any Corporate Distributorship will be recognized by Shaklee, the reverse side of this form must be completed, including the Federal Employer Identification Number. Please return all three (3) copies of the form along with a \$50.00 administrative fee to Shaklee Corporation.

The P&R, in its current form and as amended from time to time, is incorporated by reference.

Corporate Distributor Requirements

Any Shaklee Family Member may apply for recognition and approval of a Corporate Distributorship provided that all requirements, as outlined in Chapter 7 of the P&R, have been met.

Shaklee Corporation recommends that corporations only be formed after distributors consult an attorney and tax advisor in their State.

Shaklee Corporation will not review, approve or become a party to any distributor agreements other than Shaklee standard *Member Application* and *Corporate Distributor Application*. Therefore, it is not necessary to submit any Articles of Incorporation or any other corporate documents with this application form.

Upon receipt of all three (3) copies of the form and the \$50.00 fee for the processing of paperwork, Shaklee Corporation will, upon approval, update its records. Acceptance and acknowledgment of this application will be made by returning copies of the processed form to the new Corporate Distributorship and to your Business Leader of Record.

Upon acknowledgment, all correspondence transacted with the Shaklee Home Office must bear the Corporate Distributorship name and identification number and be signed by an Active Guarantor.

Shaklee Incentive Program Requirements

In general, if two or more Business Leaders form a Combined Distributorship, limitations for any Shaklee Incentive Program placed on any prospective members of the new Combined Distributorship prior to the combination will be placed on all members after the combination and no limitations will be removed by means of the combination of distributorships.

Celebration Information

Only two members per team can qualify for a Shaklee Celebration. If one team, while operating as an individual distributorship has participated in a convention or other event which is limited to one-time attendance, no allowance will be made for the team that has not attended such convention or event, once the Combined Distributorship is formed.

Bonus Car Information

A Combined Distributorship can qualify for only one Shaklee Bonus Car. If two Business Leaders, who are both Shaklee Bonus Car drivers, form a Combined Distributorship, disposition of one of the Bonus Cars must be resolved prior to processing the formation request. (This rule does not apply to Master Coordinators who are eligible to earn two cars.)

Dissolution of Corporate Distributorships

In the event of a dissolution of a combined Shaklee Distributorship held by a corporation, those provisions outlined in Chapter 7 of the P&R shall apply. A \$50.00 Administrative Fee is required to dissolve a Corporate Distributorship.
