- For people sponsored during the qualification year - If a trip is not earned, sponsoring points earned during the final 4 months of the qualification period (Mar - June) will carry over and expire at the end of the next qualification period
- For everyone else - If a trip is not earned, sponsoring points expire at the end of the qualification period and cannot be carried over to the next incentive trip

New Rank Advancement Points

- 30 Pts - Achieve Director (45 Pts if in first 3 mos)
- 50 Pts - Achieve Sr. Director (75 Pts if in first 6 mos)
- 75 Pts - Achieve Coordinator
- 100 Pts - Achieve Senior Coordinator
- 150 Pts - Achieve Executive Coordinator
- 175 Pts - Achieve Sr. Exec. Coordinator
- 200 Pts - Achieve Key Coordinator
- 225 Pts - Achieve Sr. Key Coordinator
- 250 Pts - Achieve Master Coordinator

- New Rank Points can only be assigned once for any given rank and are assigned at the conclusion of the 3 month consecutive qualification period - regardless of which qualification period qualification began in
- New Rank means never before held the rank achieved, or if you have - paid as rank was held March 2003 PV month or before
- Must attain and hold rank total of 3 consecutive months (Month of qual + 2 = 3)
- Must hold rank achieved during month of the trip
- If a trip is not earned, New Rank Points expire at the end of the trip qualification period and cannot be carried over to the next incentive trip

New Rank Advancement Points

Business Leader Development Points

First-Level

- 25 Points - Add net gain first-level (month 1)
- 40 Points - Hold first-level count (month 3)
- 50 Points - Hold first-level count (month 5)

Business Group

- 5 Points - Add net gain total recap (month 1)
- 10 Points - Hold total recap count (month 3)
- 15 Points - Hold total recap count (month 5)

- Points earned by maintaining net gain or business group count for 3 or 5 months do not need to be consecutive
- First-level or Business Group points are not awarded during waiver/vgm months
- First-Level and Business Group Point base is determined on highest number held or achieved in the prior year (July 2007 - June 2008)
- Points are only awarded at the end of months 1/3/5 that net gain First-Level or Business Group count is maintained free of waiver/vgm - regardless of period qualification began in
- If a trip is not earned, Business Leader Development Points expire at the end of the trip qualification period and cannot be carried over to the next incentive trip, but subsequent month awards (month 3 & 5) can cross qualification period and will be awarded in the month and period earned

Volume Increase Points

- 250 Points - Increase your July 2008 - June 2009 Personal Group Volume by a minimum of 30,000 over your July 2007 through June 2008 volume base

- Must maintain the same number of first-levels as highest first-level count held in the prior year (July 2007 - June 2008)
- If a trip is not earned, Volume Increase Points expire at the end of the trip qualification period and cannot be carried over to the next trip
- For base calculation, any month from July 2007 - June 2008 that you were not a Business Leader or taking a waiver/vgm, your PGV for that month will be counted as 2,000
- Minimum base is 24,000
